JUDGMENT PURSUANT TO RULE  
68 OF THE FEDERAL RULES OF  
CIVIL PROCEDURE

WHEREAS, on March 5, 2025, Defendants CITY OF MORRO BAY,  
JOSEPH COX aka JODY COX, and AMY WATKINS (collectively,  
"Defendants") served upon Plaintiff DAVID R. DURINGER an Offer of  
Judgment pursuant to Rule 68 of the Federal Rules of Civil Procedure; and  
WHEREAS, said Offer of Judgment provided for judgment to be  
entered in favor of Plaintiff DAVID R. DURINGER against Defendants CITY

1 OF MORRO BAY, JOSEPH COX aka JODY COX, and AMY WATKINS in  
2 the sum of TWENTY-FIVE THOUSAND DOLLARS (\$25,000.00), inclusive  
3 of all costs and fees incurred prior to the date of the offer, including  
4 reasonable attorney's fees awardable by statute or otherwise, and any  
5 claim for fees payable to expert witnesses or other costs that might be  
6 recoverable against Defendants in this action; and

9 WHEREAS, on March 19, 2025, Plaintiff DAVID R. DURINGER  
10 accepted Defendants' Offer of Judgment in writing, and said acceptance  
11 was served upon Defendants' counsel;

14 NOW, THEREFORE, pursuant to Rule 68 of the Federal Rules of  
15 Civil Procedure and the agreement of the parties as evidenced by the Offer  
16 of Judgment and Plaintiff's acceptance thereof:

18 **IT IS HEREBY ORDERED, ADJUDGED, AND DECREED** that:


- 19 1. Judgment is entered in favor of Plaintiff DAVID R. DURINGER and  
20 against Defendants CITY OF MORRO BAY, JOSEPH COX aka  
21 JODY COX, and AMY WATKINS, jointly and severally, in the total  
22 amount of TWENTY-FIVE THOUSAND DOLLARS (\$25,000.00).

24 2. This amount is inclusive of all costs and fees incurred by Plaintiff prior  
25 to March 5, 2025, including reasonable attorney's fees awardable by  
26 statute or otherwise, and any claim for fees payable to expert  
27

1 witnesses or other costs that might be recoverable against  
2 Defendants in this action.

4 3. This judgment fully resolves all claims asserted by Plaintiff against  
5 Defendants CITY OF MORRO BAY, JOSEPH COX aka JODY COX,  
6 and AMY WATKINS in this action. Claims against DOES 1-10, if any  
7 remain, are dismissed without prejudice, as no such defendants have  
8 been identified or served.

11 4. The Clerk of the Court is directed to enter this judgment forthwith.
